- Capstone project of the Cohort member's choice. Capstone projects are
 intended as a natural culmination of sustained effort throughout the
 calendar year. Cohort members will work with their small group leaders to
 identify capstone projects early (1 Jun) and then present their capstone work
 at ESTCP symposium in December. Examples might include a case study of
 particularly innovative project design, research on the application of existing
 commercial technology for DoD, compilation of lessons learned and
 feedback on recently completed project milestones, stakeholder interviews
 for new project funding pathways, among many others.
